- Once tuition/fees are loaded into FACTS, you will receive a notification from FACTS showing scheduled payments.

- IF you wish to change either your payment DATE or payment SCHEDULE (Full Pay, Semi-Annual, Monthly) from your prior year FACTS Agreement **please indicate above AND notify the Business Office** at [business@rcscherryhill.com](mailto:business@rcscherryhill.com) by June 1st. *IF you try to make either of these changes online, a duplicate agreement may be created.*
- Any prior year tuition must be paid in order to begin school in September unless prior arrangements have been made with the Principal and the Pastor.
